Welcome to **4 Rivers**, Stanly County's only outdoor gear consignment shop. Please take a moment to read our contract. 4 Rivers sets the prices, so please read carefully as we want you to be comfortable with our prices. Please print your personal information, sign and date.

How do consignments work?

We only accept "gently" used outdoor equipment and brand name outdoor apparel brands and sporting goods.

We are looking for quality outdoor brands like Patagonia, Black Diamond, Mountain Equipment, Merrell, Mont-bell, Prana, Marmot, Mountain Hardware, Outdoor Research, Sierra Designs, MSR and Chaco, Teva, Under Armour and Carhartt to name a few.

All items requiring batteries must have batteries so the items can be tested. All items must be in good working order.

Bikes must have tires that hold air, are inflated, have working gears and brakes so they can be taken for a test ride.

All tents will be set up in shop with an employee to ensure the condition.

All camp stoves must be tested in the store. Air mattresses will be tested overnight to ensure that they hold air.

Items that are DIRTY, RIPPED, TORN, HAVE HEAVY WEAR, have STRONG ODORS, or are MISSING PARTS will NOT be accepted for consignment.

***Please allow time for staff to go through your items while you're in the store.**

Pricing/Payments:

The sale price of each item will be negotiated between you and a staff member. We reserve the right to make the final decision on price. Generally prices will be no greater than 70% of original MSRP.

- Items priced \$0-\$299 will receive 60% of the FINAL sale price as store credit or 50% as a cash value.
- Items priced \$300-\$599 will receive 70% store credit or 60% cash value.
- Items priced \$600+ will receive 75% store credit or 70% cash value.

4ROC is **NOT** able to and **WILL NOT** make payouts in CASH. Checks for cash value are available for pick up in store on the 1st or 3rd Tuesday of every month, UPON WRITTEN REQUEST. We will mail you your check if you are NOT local.

Discounts:

Items may be discontinued at the discretion of 4ROC starting on the 1st of the month following consignment. For example, if an item is consigned on March 15th, 4ROC may discount the item on April 1st. 4ROC may thereafter further discount the item as it deems necessary. The amount and timing of the discount is solely within the discretion of 4ROC.

Items remain the property of the consignor until they are sold. 4ROC has no liability for the loss, theft, damage or destruction of consigned items. Consignor may pick up their items at any time.

After 90 days, 4ROC will send out an email notification of UNSOLD ITEMS. Items NOT picked up by the consignor within 2 weeks of the 90-day notification become the property of 4 Rivers Outdoor Gear Consignment and will be donated to a local charity.

4ROC reserves the right to refuse any item but will do its best to serve your needs.
